State Distinguished Services Award

What is the Distinguished Services Award?

The award is for a person who has given distinguished service to the Pony Club movement, but not in the same category as that required for PCAV Life Membership.

The award may be granted to persons who have given distinguished service at State, Zone or Club level.

Who is eligible?

To be eligible a nominee must:

- Consistent and sustained contribution at Club, Zone and State levels for a minimum of ten years
- Must have held office at Club or Zone level
- Must respect the aims and objectives of the Pony Club movement
- Remain objective and unbiased in all circumstances
- Have the ability to communicate with all pony club members and other personnel
- Appropriate presentation at all activities.

Nomination Procedure

- Your Club or Zone completes the Nomination form to nominate suitable candidates.
- Nomination Forms must be forwarded to your Zone Secretary by the date specified by the Zone.
- Your Zone will review all nominations and recommend suitable candidates to the State Council.
- Your Zone will then forward nominations to the State Office on or before the **31st July annually**.
- All nominations will then be presented to the State Council for consideration.
- Your Club/Zone will be informed after the State Council meeting of the success of your application.

Closing Dates

Contact your Zone Secretary for closing dates.

Zones must have nomination forms sent to PCAV State Office by the 4th Friday in June annually.
